**1. PERMISSION TO PARTICIPATE:** I, the parent/guardian of the above-named participant hereby acknowledge that my child is in good general health and I give my approval for my child to participate in any and all Pop Warner national, regional, league/conference, association and team/squad activities, including transportation to and from the activities by a licensed driver with proof of insurance.

**2. INTENT TO INFORM:** I acknowledge that I am fully aware of the potential dangers of participation in any sport and I fully understand that participation in football, cheerleading and/or dance may result in **SERIOUS INJURIES, PARALYSIS, PERMANENT DISABILITY AND/OR DEATH**. Furthermore, I fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore I do hereby waive, release, absolve, indemnify, and agree to hold harmless the local, league and regional Pop Warner organization(s), Pop Warner Little Scholars, Inc., and any and all organizers, sponsors, supervisors, participants, and persons transporting the above named participant to and from activities, from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.

**3. EMERGENCY MEDICAL AUTHORIZATION:** I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all Pop Warner activities.

**4. EQUIPMENT RESPONSIBILITY:** I agree to assume full responsibility for any and all equipment/uniforms loaned to the above named participant and I agree to promptly return, upon request, the uniform and other equipment issued to the above named participant in as good condition as when received except for normal wear and tear. If I fail to adhere to this policy, I will be responsible for the replacement cost of such equipment. I agree to furnish an authentic certified copy of a birth certificate of the above-named participant to local Pop Warner officials.

**5. INSURANCE DISCLOSURE:** I am aware that my local Pop Warner organization carries group accident insurance which is considered secondary or excess for medical purposes to any and all valid insurance I possess is considered primary insurance. Furthermore, I agree to notify in writing my head coach and local Pop Warner organization of any medical claim as a result of participation in Pop Warner as soon as reasonably possible. I understand that any registration fee paid does not constitute a direct premium for insurance and that a deductible(s) may apply.

**6. SCHOLASTIC VERIFICATION:** I hereby stipulate that either my child is scholastically fit, or that I have completed the scholastic eligibility form or the Home School Eligibility Form and will adhere to all rules and regulations therein. Furthermore, I hereby authorize my child's school to release school grades, report card results, and any and all other pertinent scholastic information to the local Pop Warner organization in order to comply with Pop Warner's scholastic fitness requirements.

**7. FINANCIAL RESPONSIBILITY:** I hereby stipulate that I have been advised by the local Pop Warner Organization of my rights, if any, to a refund in accordance with the local organization policies, and I have also been advised of my fundraising obligations for the entire season and agree to fully comply with those obligations.

**8. COMMUNICATION AND PROMOTIONAL CONSENT:** As a condition to my child's participation, I hereby consent to receive communications via email and mail from Pop Warner Little Scholars, Inc. and its partners. I understand that Pop Warner Little Scholars does not sell its contact lists and communications sent may contain program information as well as special offers and may be opted out of by following the instructions in the email or via written request to the Pop Warner National Office. Furthermore, I hereby grant to Pop Warner the absolute right and permission to make, reproduce, broadcast or otherwise use participant's name and likeness, any photograph, films, videos, recordings, or other depictions or images in whatever form or media in connection with participation in Pop Warner throughout the universe in perpetuity and in any and all advertising and promotion materials, in any manner or media whatsoever for purposes of art, advertising, editorial, trade or promotion or any other purpose whatsoever. To the extent that any benefit accrues or may accrue to Pop Warner, I hereby and forever waive any interest in or claim to such benefits and acknowledge that Pop Warner is under no obligation to exercise any rights granted herein.

**9. ADULT CODE OF CONDUCT: S1:** In order to uphold the goals of Pop Warner and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults and attendees of Pop Warner events, including but not limited to practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. **S2:** Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a Pop Warner event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave a Pop Warner event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all Pop Warner events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period. **S3:** Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all Pop Warner events for one year from the date of the offense, and their children may also be removed from any and all Pop Warner programs for that same period of time. After the ban has expired, if the individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all Pop Warner events and the individual's children may also be permanently removed from any and all Pop Warner programs.

**10. ADHERENCE TO POP WARNER RULES AND PROCEDURES:** I hereby understand and acknowledge that as a parent/guardian of a Pop Warner participant it is my responsibility to comply with all rules and regulations stipulated, adopted or recognized by Pop Warner Little Scholars Inc. or any of its member organizations and understand that any non-compliance with any and all rules and regulations may be cause for discipline and/or dismissal of the participant, myself, and/or any spectators or other persons affiliated with the undersigned and the above named participant. I further understand that the participant must meet Pop Warner age and/or weight requirements on their official certification date as established by Pop Warner Little Scholars, Inc. without exception and that the decision of the Weigh Master is final. I agree to furnish an authentic certified copy of a birth certificate of the above-named participant to local Pop Warner officials and understand that valid proof of age, a current year's signed medical release, participant contract and parental consent, and scholastic fitness forms must be presented by date of certification in order to participate further in Pop Warner activities.

**11. DISPUTE RESOLUTION POLICY:** I hereby understand and acknowledge that all civil disputes between Pop Warner and any and all affiliated parties will be subject to binding arbitration in the locale of the Pop Warner Little Scholars, Inc. National Office in Langhorne, PA in accordance with Pennsylvania law under the guidelines and rules of the American Arbitration Association. I hereby agree that this binding arbitration shall be in lieu of any litigation by and between myself, Pop Warner and any and all affiliated parties. I also understand and agree that if I contest any decision or ruling of Pop Warner Little Scholars, Inc. and seek other recourse, that I will reimburse Pop Warner for all legal fees and expenses it reasonably incurs. If any portion of this form shall be deemed unenforceable or invalid, the remainder shall remain in full force and effect.

I ALSO UNDERSTAND AND AGREE TO THE FOLLOWING:

1. **REFUNDS** --
  - FULL REFUNDS PRIOR TO UNIFORM DISTRIBUTION.
  - 50% REFUNDS BETWEEN UNIFORM DISTRIBUTION AND AUGUST 15<sup>TH</sup>.
  - NO REFUNDS AFTER AUGUST 15<sup>TH</sup>.
  - ALL REFUND REQUESTS MUST BE MADE ON A REFUND REQUEST FORM AND BE SUBMITTED DIRECTLY TO THE BOARD, AND ALL UNIFORMS MUST BE RETURNED.
  - NO REFUNDS ON RAFFLE MONEY
2. **VOLUNTEER/UNIFORM DEPOSIT** - I UNDERSTAND THAT MY UNIFORM DEPOSIT WILL BE CASHED IF:
  - I DO NOT SIGN UP AND WORK MY DESIGNATED VOLUNTEER DUTY (I.E. SNACK STAND), OR
  - I DO NOT RETURN MY UNIFORM ON TIME OR MAKE ALTERNATE ARRANGEMENTS

**PARENTAL/PARTICIPANT RULES & REGULATIONS**

Welcome to the Brick Pop Warner Dragons Cheer and Dance Programs. Practice officially starts on or about August 2, 2010. For the month of August, practice will be held Monday through Friday up to 10 hours per week. After Labor Day, practice will be limited to six hours per week.

***RULES AND REGULATIONS***

A child will not be allowed to participate at practice on (or about) August 2nd unless they meet the following criteria:

- \*1. Registration fee paid in full
- \*2. JSPWFL Doctor's certificate received
- \*3. Picture of player received
- \*4. Copy of Birth Certificate (Original may be required by Jersey Shore League Officials).
- \*5. **Copy of Report Card received (from previous ending school year).  
MUST BE LEGIBLE AND HAVE ALL FOUR QUARTERS.**
- 6. Parental Contract to participate signed
- 7. Volunteer/Uniform Contract is signed and \$100.00 deposit is paid
- 8. Participant is required to purchase Kelly green shorts and T-shirts for practices
- 9. One \$80.00 raffle ticket book is purchased (Maximum 2 books per family)

\*These are Jersey Shore Pop Warner Football League regulations and they will be strictly enforced.

As a member of the Brick Pop Warner Dragons Cheer and Dance Programs, you have made a commitment to **YOUR TEAM**. This means that any practices, games, fund-raisers, or any activity in connection with **YOUR TEAM** comes first.

Each participant must always abide by the following rules.

***A. ATTITUDE***

- 1. Always show respect towards all coaches and fellow teammates. Pursuant to Pop Warner Rules, any misconduct and/or extreme disciplinary problems by a player will result in a mandatory cut from the team. No refund of registration fee will be issued.
- 2. Always show respect for the uniform, the organization, and the town it represents.
- 3. Always show respect to other teams and their coaches.
- 4. Always stay together as a team, do not wander off.
- 5. Any confrontation, either verbal or physical by a parent or player, will not be allowed during any Brick Pop Warner Dragons event. This could result with immediate suspension from the team.
- 6. **No chewing gum** during games, practices and competitions.
- 7. **No eating** during games, practices and competitions.
- 8. No smoking, drugs, or use of alcohol.

***B. ATTENDANCE***

- 1. Attendance will be taken at each practice and game. The success of the team depends on many elements. One of the most important is the team practicing together without any players being absent. Illness will be an acceptable excuse for missing practice, however, a phone call to the Head Coach prior to the start of practice is mandatory. A doctor's note may be required.
- 2. Lateness is defined **as not being at the practice or game and ready to begin** at the time designated by the Head Coach.
- 3. All participants must arrive at game day activities at the time the coach specifies. **All participants, Cheer and Dance are required to stay for their entire game.** They must stay together and participate in game day activities to show support for their team. All participants must participate in regional and playoff games.

4. At all practices, games and competitions, each participant should bring a water bottle. Water is the best drink for athletes.
5. Please try to schedule all vacations prior to the start of the season.
6. Excessive absences may result in forfeiture of a spot on the team.

### ***C. DEMERITS***

The following is a detailed list of rules regarding practices, season play and competition. **These will be strictly enforced.**

1. Practice will be at least three times a week, unless otherwise stated by the coach.
  - a. Practice can be called any day and any time a place is available. Three (3) demerits will be given for every unexcused absence. Illness will be an acceptable excuse WITH a doctor's note for missing practice.
  - b. Excessive lateness will result in the loss of one-quarter cheering time on game day, or two (2) demerits.
  - c. Three (3) demerits will be given per incident for the following:
    - Eating while in uniform
    - Wearing jewelry, nail polish, artificial nails, improper dress (jeans, wrong socks, dirty shoes, hair not in proper manner) or forgetting your poms
    - No jewelry will be worn at practice, games and competitions**
    - Fingernails shall be kept at a length appropriate for safe participation. These are Jersey Shore Pop Warner Rules and will be strictly enforced by BPWDS**
    - Only make-up of the *clean, natural* type will be permitted**
  - d. Three (3) demerits will be given for any type of disrespect to fellow teammates or coaches. Fighting or showing poor sportsmanship will not be tolerated.
2. **IF YOU RECEIVE TEN (10) DEMERITS, YOU MAY BE DISQUALIFIED FROM COMPETITION.** Coaches are required to hand in their demerits on a weekly basis to the Coordinator. Everyone must cooperate fully at all practices, games and competitions. If there are any problems, please go through the chain of command. Speak to your Head Coach first, then to your Cheer Coordinator, then to the President then, if necessary, send a letter to the Grievance Committee.

### ***D. TRANSPORTATION***

1. It is the responsibility of the parents to see that the participant has transportation to and from all practices, games, and other activities, at the time and place designated by the Head Coach. **Please be prompt.** The coaches should not have to wait for any participant.
2. All parents must be present at least 1/2 hour before practice ends. This gives parents the opportunity to receive any daily announcements, paperwork, etc., and to ensure that parents are available to pick up their child on time from the practice field. Coaches ask for parent's cooperation in this matter so that they may also leave practice and go home at the completion of practice.
3. In case of rain, you still must report to the practice field or game site and wait to receive further instructions. Parents should remain for at least 1/2 hour in case practice has been canceled due to inclement weather. If bad weather (i.e. lightning or a thunderstorm) should occur in the middle of practice, please report back to the practice field promptly to pick up your child. **REMINDER: On game days, if the boys play, the girls cheer and dance unless the game is OFFICIALLY canceled.**
4. At least one parent or guardian or adult over 21 years of age **MUST** accompany the player to and from and be present during games. (THIS IS IMPORTANT IN CASE OF INJURY).

### ***E. APPEARANCE***

1. Hair must be worn away from the face, off the shoulders and in the style the coach requires.
2. Proper dress at practice, games and competitions is required.
3. **Jewelry of any kind is prohibited at games, practices and competitions.**
4. **Nail polish and artificial nails are also prohibited at games, practices and competitions.**  
**FINGERNAILS SHALL BE KEPT AT A LENGTH APPROPRIATE FOR SAFE PARTICIPATION.**

**F. UNIFORMS**

1. A participant will receive her uniform and poms only if her registration fee is paid, her uniform deposit is paid and any required fundraisers have been handed in.
2. During practices, all participants shall wear socks and tied athletic sneakers. Shorts, T-shirts, sweatpants and sweatshirts are appropriate for practice. Hooded shirts, over-sized shirts, jeans, jean shorts, silky or satin shorts may not be worn at practice for safety reasons.
3. Each participant will be responsible for the proper care of her uniform. **Uniforms must be clean** when they are returned at the end of the season. Uniforms should be washed separately in cool water with Woolite, on the delicate cycle and hung to dry. Uniforms **must not be dry cleaned** as per the manufacturer's cleaning instructions.
4. Parents must sign for the uniform when it is received and also sign when they return the uniform in accordance with the parental uniform/volunteer contract. Uniforms must be returned at the designated place on the first Friday of December 2010 (exception post season teams) in order to receive your uniform deposit. No other exceptions.
5. Any part of the uniform that is lost or damaged **must be replaced at your expense.**

6. If a participant leaves BPWDS, for any reason, after uniform distribution, she must return her uniform to the Cheer Coordinator at the next scheduled practice or you forfeit your uniform deposit.

**G. MEDICAL AND SCHOLASTIC FITNESS**

1. Proof of medical fitness is required. A JSPWFL doctor's exam form must be completed within five months of the same playing year, but no earlier than January 1st.
2. Proof of scholastic fitness will be required. She will not be allowed to participate for a time to be determined by the school officials.

**H. FUNDRAISING**

1. Brick Pop Warner Dragons is funded primarily through fundraising activities, therefore, each participant **MUST** participate in all fundraisers.
2. Any cost for competition will be the parent's sole responsibility to pay, however, fundraising will be made available to help recoup these costs.
3. Each Pop Warner participant is required to purchase one \$80 book of raffle tickets. (Maximum two books per family.) **Raffle money is not refundable.**

**I. REFUNDS**

**ABSOLUTELY NO REFUNDS WILL BE ISSUED AFTER AUGUST 15<sup>th</sup>** or the end of the second week of practice, whichever is sooner. In order to receive a refund, all equipment must be returned as well as a completed exit survey. The Brick Pop Warner Dragons are very interested in providing the best possible organization for the children of Brick. We are concerned when a child leaves the club and would like to know if the organization could have done something different. The purpose of the exit survey is to solicit the opinions and/or reasons why a child leaves.

### ***J. PARENTS PARTICIPATION***

Due to school regulation and insurance liability, there will be no parents allowed on the practice field or floor. This will be strictly enforced. You may only park in the parking lots. When practice commences inside, the practice will be closed to parents. **YOUR** child's organization requires ALL parents to donate at least two hours of time during the season. We need cooperation from the parents in the following areas: snack stand, and 50/50-ticket sellers, etc. Your child's team parent, who will be handling the scheduling of these assignments, will contact you. If you are not contacted, it is your responsibility to contact a Brick Pop Warner Dragon official to schedule you. Parental and volunteer contracts must be adhered to.

### ***K. COMPETITION***

All of our cheer and dance squads (with the exception of our Mitey Mites and Flag Cheerleaders) will compete in competition(s) set forth by the Jersey Shore Pop Warner Football League. If our team(s) qualify, there will also be competition(s) at the State, Regional and National levels. Once the BPWDS, Inc. Board of Directors has received and considered all of the new guidelines set forth by the JSPWFL, State, Regional and National levels for the 2010 competition(s), the BPWDS Board of Directors will have the authority to make any changes or stipulations they deem necessary.

### ***L. ALL-STAR AND SCHOOL CHEER AND/OR DANCE PROGRAMS***

According to Mid-Atlantic Region Rules, cheerleaders and cheer dancers may try out for and participate in fund-raising for a non-Pop Warner cheer or dance team during the Pop Warner season. They may not be rostered on a non-Pop Warner cheer or dance team, and they may not compete on that team until their commitment to their Pop Warner football team and their commitment to their Pop Warner competition season is completed. If these guidelines are not adhered to, the participant will be removed from our Dragon team, and will not be eligible for a refund. REMEMBER: During your BPWDS season your commitment to the Dragons comes first!! BPWDS participants are encouraged to attend tumbling classes and dance classes to enhance their talents.

### ***M. VOLUNTEER REQUIREMENT***

The volunteer requirement can be fulfilled by donating a minimum of 2 hours (during a season) of your time in assisting on various duties. You are responsible for scheduling your own date and time. These duties include the following:

- Coaching - (Must be selected by head coach after submitting application)
- Snack Stand - counter help at snack stand, 50/50 sales, etc.
- Team Mom - (One per team)

**(You must sign the Duty Roster in the snack stand each time you work in the snack stand)**

It is your responsibility to make sure your time is recorded. Failure to return the uniform and participate as stated above will result in forfeiture of your uniform deposit.

### ***O. INJURY CLAIMS***

Please remember, we will do everything we can to make this process work as smooth as possible, however, the timely filing of all injury claims is your responsibility. The Brick Pop Warner Dragons have no responsibility, beyond our medical insurance policy, to pay any medical expense incurred as the result of an on-field injury.

In the event that your child is injured during a practice or game, it is important that he or she gets the appropriate medical care immediately. The Brick Pop Warner Dragons carries insurance for such incidents but it is also important that you **understand and follow the process of medical claim submission**. If an injury does occur **you should let the head coach know immediately**. He will give you an accident report to fill out. Please be advised that the Pop Warner insurance is always secondary to any other insurance coverage you may have. This means that you must submit all associated medical bills to your **primary insurance carrier first**.

If there are still balances due after the primary insurance makes their payments, you must submit the balance due bills along with a **fully completed claim form** to the Brick Pop Warner Dragons 2<sup>nd</sup> Vice President. Your Head Coach or Team Parent should be able to lead you to him/her or you can contact him/her via our website, [www.brickpopwarnerdragons.com](http://www.brickpopwarnerdragons.com). **All claims must be submitted to our insurance company within 90 days of the injury** so it's important that you follow-up on all bills in a timely matter.
